



## **Veteran's Giveaway - Official Contest Rules, Terms & Conditions**

Note: Nominees must be willing to participate in any media interviews or publicity activities associated with the contest and have accepted the terms of the contest as stated in the Official Rules. Finalists will be asked to provide proof of military service. As a material condition of and in consideration for entry and eligibility to win, Nominees must grant Broadview Heating & Air Conditioning, Inc. and/or its designated affiliate an irrevocable royalty free license to use, exploit and publish Nominees' name, image, approved biographical information, and likeness in all media with regard to the Giveaway and further agree to execute any and all documents reasonably requested by Broadview Heating for purposes of lawfully establishing such license.

### Official Rules:

Broadview Heating & Air Conditioning, Inc.'s "Veterans Giveaway" promotion ("Contest") is sponsored by "Broadview Heating & Air Conditioning, Inc." or "Company". This contest is governed by these official rules ("Official Rules"). The Contest is open to legal residents of the United States where not prohibited by law, who are eighteen (18) years of age or older and are Veterans of any branch of the US Military (discharged under general or honorable conditions, must have a DD214), Active-Duty Military (any branch), National Guard, Reserves, or military family members (surviving spouse or spouse of Active-Duty Military) residing within Northeastern Ohio (Cleveland, Ohio area – radius of 35 miles from 4111 E. Royalton Road, Broadview Heights, Ohio). In addition to all other eligibility requirements, eligible contestants must be permanently residing in a home address within 35 miles of downtown Cleveland, as well as internet access and a valid and verifiable e-mail account prior to the beginning of the Contest Period. Broadview Heating & Air Conditioning, Inc. has the right to verify the eligibility of each entrant, including requesting verification of military service or affiliation, as well as visiting the nominee's residence for a consultation regarding the installation or repair. ### 2025 Autumn Contest Period:

The Contest begins Wednesday, October 1, 2025, at 12.01 a.m. EST and ends Friday, October 31, 2025, at 11:59 pm EST.

### How to Enter:

Friends, family or individuals may nominate a contestant for a furnace giveaway or furnace repair, a hot water tank giveaway or repair and/or an electrical project giveaway or repair. One (1) Grand Prize (furnace, hot water tank or electrical project) will be given away and three (3) repairs (furnace, hot water tank or electrical) will be given away, all to different winners.

Contestants can enter the Contest through the Broadview Heating & Air Conditioning, Inc. website and are eligible to receive one (1) furnace or hot water tank or electrical project including standard installation and manufacturer warranties and free one-time installation from Broadview Heating & Air Conditioning, Inc.

Contestants can enter the Contest through the Broadview Heating & Air Conditioning, Inc. website and are eligible to receive one (1) furnace, hot water tank or electrical repair. A total of three (3) repairs are available for three (3) different contestants.

### Submission Period:

Visit Broadview Heating & Air Conditioning, Inc.'s website and follow the instructions to submit a nomination that describes why the nominee should receive a free furnace, hot water tank, electrical project or repair, as well as a story of the hardship along with photo of the Nominee. The submission period is open from Wednesday, October 1, 2025, at 12:01 a.m. EST to Friday, October 31, 2025, at 11:59 p.m. EST. Broadview Heating & Air Conditioning, Inc., in its sole and exclusive discretion, will determine eligibility of each submission to determine the list of no more than five finalists.

Finalists will be selected based on criteria including need of individual nominated, completion of nomination form which requires a photograph of the Nominee, scope of military service, contributions to the community, proof of permanent residency in designated geographical areas, and availability to be interviewed by Broadview Heating & Air Conditioning, Inc. to determine condition and location of current furnace for replacement or repair.

There will be one (1) Grand Prize furnace, hot water tank or electrical project winner and three (3) Second Prize repair winners. The winners will be announced on the Broadview Heating & Air Conditioning, Inc.'s Facebook page on Tuesday, November 11, 2025. The winner will be chosen by a panel of Veterans employed at Broadview Heating & Air Conditioning, Inc.

Broadview Heating & Air Conditioning, Inc. reserves the right to extend, shorten, or terminate the Contest at their sole discretion. Finalists are required to give Broadview Heating & Air Conditioning, Inc. ample opportunities and access to physically inspect the home furnace, including internal and external systems, to determine if Broadview Heating & Air Conditioning, Inc. has the technical ability and legal authority to safely replace the unit without undue burden or cost exceeding \$10,000. Finalists may be disqualified if their homes have poorly maintained or dangerous environments that could hinder proper and safe removal, installation, and performance of the new unit which include, but are not limited to, unsafe conditions of the property or its inhabitants, including unrestricted pets, faulty electrical or gas systems, poorly maintained duct work and/or systems work, and other technical issues.

If no finalists meet all the requirements, Broadview Heating & Air Conditioning, Inc. reserves the right to forgo selecting a winner at the Company's discretion.

## Winner Selection & Prizes

For Broadview Heating & Air Conditioning, Inc.'s "Veterans Giveaway" promotion, Broadview Heating & Air Conditioning, Inc. will award one (1) Grand Prize to one (1) winner in Northeastern Ohio and three (3) Second Prizes. The furnace, hot water tank or electrical project will be installed according to the availability of the winner(s) and Broadview Heating & Air Conditioning, Inc. after the conclusion of the contest any time after Wednesday, November 19, 2025. The Grand Prize winner is eligible to receive one (1) furnace, hot water tank or electrical project including standard installation and manufacturer warranties and free one-time installation from Broadview Heating & Air Conditioning, Inc. Broadview Heating makes no representations or warranties, express or implied as to fitness for particular purpose, no service or duct work is included as part of the Grand prize. The Second Prize winner, a total of three different individuals are eligible to receive one free (1) repair for a furnace, hot water tank or electrical system from Broadview Heating & Air Conditioning, Inc. The company will do its best to repair, however if the unit is beyond repair, Broadview Heating is not responsible for a replacement. In the event the winner cannot be reached and/or does not respond within a 72-hour period of time from the time of initial outreach, they forfeit the prize, and the next candidate shall receive the prize.
